Electronic/Digital Artwork Specifications

Files saved as .pdf are preferred but we will also accept .psd; .eps; .tiff; .jpg.

Use the following settings when making PDFs:

- * Postscript level 2
- * Version Acrobat 4 (1.3)
- * All fonts embedded
- * Layers & transparencies flattened
- * OPI turned off

We can accept native documents in the following programs:

- (All fonts and images must be sent as well.)
- * InDesign CS2 or lower
- * Photoshop
- * Illustrator CS
- * QuarkXpress 6.5 (Mac) or lower

Color:

We can accept only process CMYK colors.
All blacks must be black only, not registration or rich black.

Resolution:

4-color CMYK & grayscale art resolution:
300 dpi max./150 dpi min.
Line-art resolution: 600 ppi min.

- Restrictions:** Message must support the mission of the Catholic Church.
- Placement:** Ads receive premium placement on the back page of each issue.
